Sub : Implementation of National Tobacco Control Programme (NTCP) – Reg.

Sir/Madam,

Enclosed herewith please find the copy of NVS Hqrs. letter.No.16-5/2017-NVS(SA)/1180 dated 18.01.2018 together with guidelines of NTCP regarding implementation of National Tobacco Control Programme in JNVs. The Government of India has enacted the National Tobacco-Control Legislation namely, “The Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003” in May, 2003.

Smoking in Navodaya Vidyalaya Complex will not be permitted. A notice board is to be displayed at a conspicuous place(s) outside the premises, prominently stating that sale of cigarettes and other tobacco products in an area within a radius of one hundred yards of the educational institution is strictly prohibited. Board also to be displayed prominently at least one at the entrance. It should contain the warning namely, “No Smoking Area, Smoking in the campus is an Offence “Tobacco causes cancer” or “Tobacco Kills”. The Tobacco Act and other Rules have to be posted on official Web Site of JNV. Every year 31st May is to be celebrated as “world No Tobacco Day”.

It shall be ensured that Tobacco Smoking is not done in the presence of the students. No ash-trays shall be placed in the office of the Principal in Navodaya Vidyalayas. Strict compliance is requested. Please acknowledge the receipt of this letter and action taken in the matter may please be confirmed to this office on or before 05.02.2018.
